This Privacy Policy explains in detail our practices concerning your personal information and your rights under applicable privacy laws.

## 1. Information We Collect

TLCF may collect a variety of personal information, depending on your interaction with us. This information helps us deliver services, communicate effectively, and fulfill our mission. The types of data we may collect include:

#### Personal Identification Information

This includes basic information that identifies you personally, such as:

#### • Financial Information

In order to process donations, payments, and financial transactions, we may collect financial data, such as:

- Payment card information (through secure payment processors)
- Donation history (amounts and dates of donations)
- Billing and shipping address (for donation receipts or merchandise)

#### Photos and Videos

As part of TLCF's documentation and promotional efforts, we may collect and use images, videos, and audio recordings captured at events, programs, or in public spaces where TLCF is involved. These may be used for:

## Website Usage Information

- Device type and operating system
  This data helps us improve our website and customize it to better suit your needs.

### 2. How We Use Your Information

We use the information we collect to advance the goals of TLCF and to ensure a smooth and effective experience for you. Below are the key ways we use the personal information we gather:

### Program and Service Delivery

The primary use of your personal data is to ensure we can provide the programs, services, and activities that you have engaged with. This includes:

- Registering you for events, workshops, or courses
- Tailoring program content to your specific needs or preferences
- Processing requests for services or resources
- Sending reminders, updates, and other important notifications related to your participation

#### Communication

We may use your contact details to communicate with you about:

- Highlighting the positive impact of TLCF programs through multimedia content

#### 3. How We Share Your Information

At TLCF, we are committed to maintaining your privacy and confidentiality. We do not sell or rent your personal information to third parties. However, we may share your data in specific circumstances:

#### Service Providers

We work with third-party vendors who assist us in performing various services, including:

- Payment processing (for donations or fees)
- IT services (website hosting, data storage, and maintenance)
- Marketing and email communications
  These service providers have access to personal data but are restricted from using it for purposes other than those specifically authorized by TLCF.

#### Affiliated Organizations

We may share your information with organizations that collaborate with us to provide programs or services. These organizations may include:

- Partnering charities or nonprofits
- Educational institutions offering joint initiatives

Sponsors of events or fundraising efforts
 These affiliates will only use your data for purposes related to the partnership.

## • Legal and Regulatory Authorities

In some cases, we may be required to disclose personal information to legal authorities, such as:

- Responding to subpoenas or legal requests
- Protecting our rights and interests or those of our partners
- Complying with applicable laws or regulations

#### Public

Photos and videos taken at public events, or in public spaces, may be shared via our communication channels. This includes social media platforms, newsletters, and marketing materials.

# 4. Data Security

TLCF is committed to maintaining the security of your personal information. We have implemented physical, technical, and administrative safeguards to protect against unauthorized access, alteration, disclosure, or destruction of your personal data. These measures include:

- Firewalls and antivirus protection to guard against external threats
- Access control policies that limit the exposure of sensitive data to authorized personnel only

While we strive to protect your information, no method of electronic communication or storage is completely secure. Therefore, we cannot guarantee absolute security, but we take all reasonable precautions to safeguard your data.

### 5. Retention of Information

TLCF retains your personal information only for as long as necessary to fulfill the purposes outlined in this Privacy Policy or as required by law. When the data is no longer needed for these purposes, we will securely delete or anonymize it to protect your privacy. Retention periods vary depending on the type of data and applicable legal or regulatory requirements.

# 6. Your Rights

As an individual whose data we collect, you have specific rights under privacy laws that allow you to control the information we hold about you:

- Access: You may request access to your personal information that we maintain and obtain a copy of the data.
- Correction: You can request corrections to any inaccurate or incomplete information.

- **Deletion**: You may request the deletion of your personal data, subject to legal and contractual obligations.
- **Opt-Out**: You have the right to opt out of certain communications, such as marketing emails or newsletters, and request restrictions on certain uses of your data.
